



Race Day Member's Guest & Owners Ticketing Entitlements

Ticketing Entitlements

Entry to the Course

- Each Owner named in the Race Book PLUS a guest will be entitled to free entry to the race course on the day their horse is running.
- Members of Syndicates with a share in a horse engaged on the day not specifically named in the race book will also be entitled to free entry to the course.

Members and Mounting Yard Tickets

- The Club will distribute a maximum of 40 Members Passes per horse.
- The Club will distribute a maximum of 20 Mounting Yard Passes per horse for space and safety reasons.
- Each Owner named in the racebook will be entitled to a Members Day Pass providing access to Members' Areas (excluding the First Floor Members Only Bar) together with a Mounting Yard Pass providing access to the Mounting Yard for the relevant race.
- Members of Syndicates who own a share in a horse engaged on the day who are not specifically named in the book will also be entitled to a Members Pass and Mounting Yard Pass if the Syndicate Manager informs the Club before the day of the race meeting of members attending and there are sufficient tickets available within the maximum per horse.
- Additional passes may be provided to guests accompanying owners at the discretion of the Club subject to availability.
- NOTE: Dress regulations apply in Members Areas.

Complimentary Beverage Vouchers

- Each Mounting Yard Pass is also a voucher that may be redeemed at any bar at Morphettville for a complimentary beverage (tap beer, house wine or soft-drink).
- Vouchers are only valid on the day of issue and should be redeemed after your race to ensure access to the Mounting Yard is granted for your race.

Ticket Collection Requirements

Photographic Identification must be provided

- At the point of entry to the course to gain free admission to the course; and
- In conjunction with an "Owner Sign-In Form" completed at the Race Day Office to obtain Members and Mounting Yard passes.
- The Owners name on the Identification provided will be referred to the official list of Owners as published by RISA to confirm entitlements.

Syndicate Ticketing Requirements

- Each syndicate manager is responsible for providing the Club with a list of names before the day of the race meeting of the syndicate members who are to receive the Owners' entitlements.
- If no names have been sent prior to the meeting, then the only person who can pick up the tickets for the syndicate is the syndicate manager.

Representatives attending on behalf of Owners

- If an Owner is not going to be in attendance and has a representative acting on their behalf (including providing a co-Owner with additional entitlements), the Club must receive a signed letter from the non-attending Owner giving Authority for the representative to receive the owners entitlements.

Collection of Tickets Prior to Race Day

- If an Owner wishes to collect ticketing before the race day they must sign a declaration confirming they understand no further ticketing will be issued.
- If an Owner wishes for a representative (including the Trainer or a co-Owner) to collect ticketing prior to the race day, the Club must receive a signed letter from the Owner giving Authority for the representative to collect the entitlements on their behalf.
- Ticketing will not be issued prior to acceptance being taken for a race meeting.
